Proposed amendments to Article 10., Section C. of the Declaration of Condominium Establishing the River Mews, Phase 1, A Condominium:

- 10. USE RESTRICTIONS The use of the property of the condominium shall be in accordance with the Rules and Regulations attached as Exhibit "R" and the following provisions:
 - C. REGULATIONS Reasonable regulations concerning the use of the condominium property may be made and amended from time to time by a seventy five percent (75%) majority wote of the association voting interests represented in person or by proxy at a duly held meeting of the owners at which a quorum is present. Copies of such regulations and amendments thereto shall be posted conspicuously and shall be furnished by the association to all unit owners. No regulation may discriminate against any group or class of users. No new or amended rule or regulations may be enforced prior to approval by the owners.

Proposed deletions are lined through and proposed additions are underlined.

 - C. REGULATIONS Reasonable regulations concerning the use of the condominium property may be made and amended from time to time by a majority vote of the voting interests represented in person or by proxy at a duly held meeting of the owners at which a quorum is present. Copies of such regulations and amendments thereto shall be posted conspicuously and shall be furnished by the association to all unit owners. No regulation may discriminate against any group or class of users. No new or amended rule or regulations may be enforced prior to approval by the owners.
