



- I. Paragraph 23 of the above referenced Declaration of Condominium shall read as follows:
 - 23. Automobile Parking Spaces and Storage Spaces. The location and dimensions of automobile parking spaces and storage spaces are as more particularly described on the plan which is attached hereto as Exhibits "2-A and 21-A" and Exhibits "3-A and 22-A", respectively, and are each identified numerically on such plan. One such parking space and storage space shall be assigned to the exclusive use of each Unit owner so that the occupants of each Unit will be entitled to one (1) parking space for one (1) automobile and one (1) storage space. The initial assignment of each parking space and storage space shall be made by the Developer. Subsequent assignments may be made by each Unit owner, or by operation of law, to any other Unit owner in exchange of spaces or the sale or transfer of a Unit, or to the Association provided a Unit always has an assigned parking space and storage space. Every assignment and reassignment of a parking space and storage space shall be

evidenced by a Certificate issued by the association and such Certificate shall be transferable upon the books and records of the Association.
