3.30 **Rental Restrictions.**

Only entire Dwelling Units may be rented. No rooms may be rented and no transient tenants accommodated. No Owner may lease his or her Dwelling Unit more than once in a twelve (12) month period, measured from the commencement of the most recent prior lease. No lease may be for a term of less than six (6) months. Vacant Lots may not be leased for any purpose. A Dwelling Unit shall be considered leased any time it is occupied by a tenant.
