

**CERTIFICATE OF
AMENDMENT TO THE
BYLAWS OF

The Bylaws of The Gables of Vero Beach Condominium Association, Inc. has been recorded in the public records of Indian River County, Florida at Official Records Book 770, Page 87, et. seq. and amended at Official Records Book 814, Page 788 ½, et. seq., Official Records Book 822, Page 193, et. seq., Official Records Book 822, Page 195, et., seq., Official Records Book 1041, Page 611, et. seq., and Official Records Book 1372, Page 1307, et. seq. The same Bylaws are hereby amended as approved by a majority of the Board of Directors at the meeting held on February 19, 2016, and by a majority of the members, said approval occurring at the Membership Meeting held on May 17, 2016.


(The balance of Article III remains unchanged.)



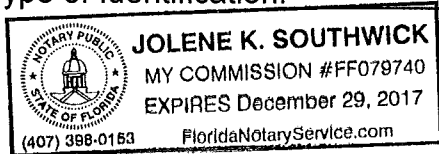

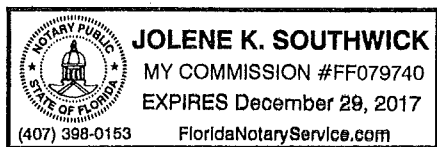
