MEMBERSHIP CATEGORY PRIVILEGES

Members of the same membership category will pay the same annual rate of dues and other costs associated with said membership such as Food and Beverage Minimum, monthly or capital assessments.

Gold Membership - Full

Golf members shall be entitled to complete access to and use of the Club's facilities in accordance with the Club's rules and regulations. The designated individual member has full voting privileges. Vertical Family— Permits children, grandchildren, parents + grandparents of members and their spouses to have privileges (provided such family members do not own or lease within 100 miles of Indian River Club). This category does have an Initiation Fee.

Bronze Membership

Full golf members under the age of 50 shall be entitled to complete access to and use of the Club's facilities in accordance with the Club's rules and regulations. The designated individual member has full voting privileges. This category does not have vertical membership privileges and has an initiation fee.

Social Membership

Social members shall be entitled to use the Club's social facilities, social events and social clubs, including the clubhouse, pickleball, pool, and fitness center, and may utilize a fee-based driving range plan. Limited golf privileges are available, depending on the social membership plan selected. Only use of reciprocal arrangements for dining and other non-golf amenities are included. Social members do not have voting privileges and may not hold office.

INITIATION FEE: I submit with this Agreement a check made payable to The New Indian River Club, d/b/a Indian River Club (the "Club") for the total amount of \$_____, the non-refundable Initiation fee. The non-refundable Initiation fee is due and payable in full with this Agreement. If an Addendum modifies this Agreement, failure to pay the balance of the Initiation fee when due shall permit the Club, in the sole and absolute discretion, to terminate my membership without refund of the portion of the Initiation Fee and previously paid and dues or other fees paid for the year of termination, in addition to any other disciplinary action the Club may determine In its sole and absolute discretion.

BRONZE MEMBERSHIP CONVERSION: Upon turning 50 before October 1st in any given year, Bronze members will have membership options for the following fiscal year:
1) Upgrade to a Gold membership for a fee of \$5,000.
2) Transition to a Silver membership for no fee.

APPROVAL FOR MEMBERSHIP: I understand that I will only be entitled to membership privileges and be considered a member once the Club approves this Agreement. The Club will determine, in its sole discretion, whether an Agreement has been approved.



MEMBERSHIP PRIVILEGES IN THE CLUB: I acknowledge that the Club will operate the Club Facilities and that membership permits the member to use the Club Facilities. However, membership is not an investment in the Club or the Club Facilities, nor does it confer on the member any equity or ownership interest or any other property interest in the Club or the Club Facilities. Membership does not give a member a vested or prescriptive right or easement to use the Club Facilities but grants the member a revocable license to use the Club Facilities by the terms of the established Membership Plan.

RESIGNATION: Resignation is permitted only in accordance with the Bylaws. All membership dues and capital adds are annual obligations and are defined based on a 12 month period due and payable as of Oct 1st for the following Club year ending Sep 30th. If the resigning member pays dues/capital adds monthly, the member will be liable for any unpaid dues/capital adds/charges for the remainder of the Club year. If the resigning member paid all dues/capital adds in full at the beginning of the Club year, there will be no refund and they will be liable for any outstanding charges and capital dues owed for the remainder of the club year. The membership may not be pledged, assigned, transferred, or hypothecated in any manner by the Member.

CLUBHOUSE MINIMUM AND OTHER CHARGES: I hereby acknowledge that I may be charged a periodic Clubhouse minimum in the amount determined by the Club from time to time. Any Clubhouse minimum will not be carried over to a subsequent period. I acknowledge and agree to be responsible for clubhouse minimums and all other charges incurred, which shall be due and payable no later than thirty (30) days from billing. Past-due balances will be subject to a 1.5% Interest charge per month.

MEDIA AND LIKENESS RELEASE: Member grants the Club the perpetual, irrevocable right to use Member's name, image, likeness, and voice captured during club activities or on club premises for promotional, marketing, and advertising purposes in any media format, including print, digital, and social media. Member waives any right to compensation or approval and releases the Club from related claims. Member may opt out of future use by written request, though previously published materials may continue to be used.



VERIFICATION OF AGREEMENT: Upon signing this Application, Applicant and Applicant's Spouse or Partner (if any) each authorize the disclosure and release of Information to the Club for investigating qualifications for membership, including, without limitation, credit histories, and authorize those persons or entities listed herein to furnish information to the Club. Applicant and Applicant's Spouse each agree that all information and communications received by the Club are privileged, confidential, and not subject to disclosure to the undersigned or any other person other than authorized Club personnel. The undersigned each agree never to make a demand on the Club or any other person to disclose any information or communications to the undersigned, and the undersigned releases the Club and its members, partners, officers, directors, shareholders, employees, representatives, affiliates, and agents and any person providing information or communications from any liability in connection in addition to that.

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida, without regard to principles of conflict of laws.

I understand that acceptance and continuation of membership are subject to payment of the applicable non-refundable initiation fee, dues, Clubhouse minimums, and other charges as may be charged from time to time by the club. I also understand and will abide by all rules, regulations and Bylaws established by the club.
