Section 2. ARC. There shall always be an odd number of members on the Architectural Review Committee. The ARC shall have authority to review and approve plans and specifications for the location, size, type or appearance of any structure or other improvement on a parcel, or to enforce standards for the external appearance of any structure or improvement located on a parcel. This committee shall report all instances on non-compliance of homeowners to the Board of Directors or such Compliance Committee as the Board of Directors may create and appoint from time to time.
