FIRST AMENDMENT TO THE DECLARATION OF COVENANTS AND RESTRICTIONS FOR OAK CHASE

WHEREAS, the Declaration provides that the Declaration may be amended by the Developer, until a Certificate of Termination of Interest in the Association has been executed and recorded by Developer, without the joinder and consent of any owner, institutional mortgagee, or any other party;

WHEREAS, the Developer presently owns all of the property which shall be the subject of this Amendment, and the operation of the Association continues to be controlled by Developer; and

WHEREAS, the Developer wishes to amend the Declaration in accordance with its terms.

NOW, THEREFORE, pursuant to the terms of the Declaration, the Developer hereby makes the following amendments:
