occupancy agreement must be for a period of not less than three (3) months and

not to exceed three (3) times within a twelve (12) month consecutive period. For

rental and occupancy periods less than three (3) months, the Owner must submit

the request for approval to the Board of the Association prior to the

commencement of the rental term for its review and consideration.
