- 9. Article IV, Section 4, line 2, the words <u>generally</u> and are hereby added after the word <u>duties</u> and before the word <u>as</u>.
- Article IV, Section 4, line 2, the word <u>member</u> is hereby changed to <u>participant</u>.
- 11. Article IV, Section 6, line 3, the words <u>or deceased</u> are hereby deleted.
- 12. Article IV, Section 13, line 8, the word <u>person</u> is hereby changed to <u>persons</u>.
- 13. Article IV, Section 14, line 6, the comma after the word meeting is hereby deleted; and the words and a waiver are hereby added between the word meeting and the word any.
- 14. Article IX, line 9, the word <u>or</u> is hereby changed to and/or.

Except as specifically set forth herein, the By-Laws shall remain unchanged and in full force and effect and are specifically reaffirmed.
