7.3 <u>Limited Common Elements</u>.

7.3.1 <u>Balconies</u>. Except as provided below, each Unit Owner shall, at his sole cost and expense, maintain the surface of the floor, ceiling and walls of any balcony that is appurtenant to his Unit as a Limited Common Element, the surface of the interior face of any parapet that partially surrounds that balcony and any wiring, electrical outlets, light bulbs and other fixtures located on or in that balcony. The Association shall be responsible for the maintenance, repair and replacement of any structural elements of any floor, ceiling, wall, parapet wall and railing of any balcony serving a Unit. Additionally, the Association shall be responsible for the painting of the balcony railings serving a Unit.
