- 1. The old Paragraph 12.6 is deleted in its entirety and a new Paragraph 12.6 is added to the Declaration which shall read as follows:
  - "12.6 <u>Developer's Liability for Assessments</u>: The Developer guarantees that a Unit Owner's assessment shall not exceed \$462.74 per month from February 1, 2007 until after December 31, 2011. The Developer has the option to extend the guarantee for one (1) more year through December 31 2012. However, the Developer must pay the portion of Common Expenses incurred during that period which exceeds the amount assessed against other Unit Owners.
