Article 4, Paragraph 4.8 of the above referenced Bylaws shall be amended to read as follows:

4.8 A quorum at a Directors' meeting shall consist of the Directors entitled to cast a majority of the votes of the entire Board. The acts of the Board approved by a majority of the Board present in person or by telephone or video conference at a meeting at which a quorum is present shall constitute the acts of the Board. If at any meeting of the Board there shall be less than a quorum present, the majority of those present may adjourn the meeting from time to time until a quorum is present. When a quorum is present after adjournment of a meeting, any business that might have been transacted at the meeting, as originally called, may be transacted without further notice.

Article 10, Paragraph 10.1 of the above referenced Bylaws shall be amended to read as follows:

10.1 A resolution for the adoption of a proposed amendment to these Bylaws may be adopted by a vote of a majority of the Voting Interest of the Association present, in person or by proxy, and voting at a duly noticed meeting at which a quorum is present. Amendments correcting errors, omissions, scrivener's errors, violations of applicable law, or conflicts between the Association Documents, may be executed by the Officers of the Association, on Board of Directors approval, without the need for Association membership vote.
