**TOPIC:** NOTICE FOR FAMILY / FRIENDS OCCUPANCY

(When owner is not in residence)

ADOPTED: August 22, 2013

**REVISED:** July 2023

1. Elliott Management must receive the completed notification at least 7 days prior to the date of occupancy.

- 2. All Family/Friends occupancy must have a start and end date.
- 3. No Family/Friends occupancy may be more than 60 consecutive days.
- 4. Occupancy may be only by family members or friends and their children who are named on the application.
- 5. Motor homes, truck mounted campers, travel trailers, pickup trucks with a capacity of 3/4 ton or over, pickup trucks that are used primarily for transportation of cargo or which contain equipment or tools visible from the exterior, semis, tractors, tractor trailers, windowless vans, commercial vehicles of any type, recreational vehicles, buses, swamp buggies, dune buggies, boats and/or trailers may not be kept on condominium property. Applicant(s) hereby grants Seaward at Atlantic View Association, Inc. the right to remove any prohibited vehicle owned or used by the Applicant(s) as noted above and defined by the condominium documents. The unit owners will pay all costs of removal, storage, and any legal fees or costs incurred by Seaward. Unit owners shall hold Seaward and its representatives harmless in any such event.
- 6. Only one pet in residence under 35 lbs. Pet regulation 16.3 of the Seaward Declaration applies and is enforced.
- 7. The unit owners must provide the Family/Friends occupant(s) with a copy of the Association Rules and Regulations.
- 8. Occupancy regulations: Occupancy must not exceed two (2) adults or three (3) children per bedroom.
- 9. The unit owner is responsible for any damage to the Seaward property caused because of the behavior of family or friends. The unit owner accepts that any violation of the terms, provisions, conditions, and covenants of association documents may provide cause for immediate action, including possible termination of the occupancy under appropriate circumstances.
