ARTICLES OF AMENDMENT

TO

AMENDED DECLARATION OF CONDOMINIUM 274628

OF

KENTUCKY CLUB CONDOMINIUM

WHEREAS, KENTUCKY CLUB CONDOMINIUM (hereinafter, the "Condominium"), the Amended Declaration of Condominium of which is filed in Official Record Book 607, at Page 2370, of the Public Records of Indian River County, Florida, (hereinafter, the "Amended Declaration"), is the result of a merger of two neighboring, pre-existing, and separate condominiums, to wit: Kentucky Club, a Condominium, the original declaration of condominium of which is filed in Official Record Book 562, at Page 1505, of the Public Records of Indian River County, Florida (such original condominium being hereinafter referred to as "Building B"), and Lexington House, a Condominium, the original declaration of condominium of which is filed in Official Record Book 607, at Page 2306, of the Public Records of Indian River County, Florida (hereinafter, "Building A"). In the text of and the exhibits to the Amended Declaration, Building A is referred to as Building A, and Building B is referred to as Building B;

WHEREAS, Building A has six stories, the lowest of which, on the ground level, is divided into parking spaces for the owners of units in the building and also contains a reception area, lobby, elevators, storage rooms and other facilities. Each of the five stories above the ground floor used for parking contains five separate condominium units, for a total of twenty-five units in Building A;

WHEREAS, subsequent to the filings of the two original declarations of condominium of Buildings A and B, subsequent to the delivery by the developer to purchasers of deeds transferring title to units, subsequent to the obtaining of purchase money mortgages on such units by Kentucky Central Life Insurance Company, subsequent to the merger of the two original condominiums, and subsequent to the recording of the Amended Declaration, it was found that the deeds and mortgages on the one hand, and the texts of and exhibits to the Amended Declaration on the other, apply different identifying numerals and letters to each of the condominium units in Building A;

WHEREAS, both the floor plans attached to, and the text of, the Amended Declaration refer to the southernmost apartment on the floor immediately above the ground floor used for parking as Unit "101A". Other units on the same floor are numbered accordingly through 105A. The initial numerals of the three-digit appellations used in the Amended Declaration exhibits and text for each of the units on floors above the first floor proceed logically from one to two (2) through five (5), the easternmost unit on the top story of Building A being known in the Amended Declaration as Unit 505A;

WHEREAS, no extant deed or mortgage refers to any unit known by a three-digit number commencing with "1" (one). The lowest such three-digit appellation occurring in the extant deeds and mortgages is "201". Extant deeds and mortgages do reveal five units in Building A with three-digit appellations commencing with the number six (6), and progressing from 601A to 605A;

WHEREAS, the conflict between the deeds and mortgages, on the one hand, and the exhibits to and text of the Amended Declaration, on the other, results in duplicate and contradictory identifying appellations for each of the units in Building A;

WHEREAS, the aforesaid conflict operates to cloud the titles of unit owners and mortgagees of units in Building A, and it is therefore in the interests of such unit owners and mortgagees to take such action or actions as shall resolve and set to rest the aforesaid conflict;

WHEREAS, the unit owners and mortgagees of both Buildings A and B of the Condominium desire to resolve the said conflict through appropriate amendments to the Amended Declaration, and the amendments to the Amended Declaration

Prepared by: Kramer, Roddenberry, Palmer, Jaffe & Palmer 3339 Cardinal Drive, Vero Beach, Florida 32960 and its text and exhibits contained in this present document are intended to resolve the aforesaid conflict through the conforming of the identifying appellations for each of the units in Building A as used in the Amended Declaration, its text and exhibits, to the identifying appellations used in the extant deeds and mortgages, and thereby resolve the conflict between the said deeds and mortgages on the one hand, and the text of and exhibits to the Amended Declaration on the other.

NOW, THEREFORE, the undersigned, being all of the record owners and mortgagees of units in KENTUCKY CLUB CONDOMINIUM, a condominium lying in and being located upon lands in Indian River County, Florida, more particularly described as follows:

Lots 4, 5, and 6, Block 14, THE OCEAN CORPORATION SUBDIVISION, according to the plat thereof recorded in Plat Book 3, Page 9, Public Records of Indian River County, Florida,

do by these presents amend and modify, and do hereby ratify and confirm the within-contained amendments and modifications of, the Amended Declaration of Condominium of KENTUCKY CLUB CONDOMINIUM, recorded in Official Record Book 607, at Page 2370, of the Public Records of Indian River County, Florida, as follows:

ARTICLE I

Paragraph V(E)(a) of the Amended Declaration, recorded in Official Record Book 607, at Page 2375, of the Public Records of Indian River County, Florida, is hereby amended to read as follows:

"(a) Apartment Building. The condominium includes two buildings, one being a four (4) story building containing twenty (20) condominium units, and the other being a six (6) story building containing twenty-five (25) condominium units. The six (6) story condominium building is designated Building 'A', and the four (4) story condominium building is designated Building 'B'.

"All apartments in Building 'A' are either on the second, third, fourth, fifth or sixth floor, and the first floor or said building contains twenty-three (23) covered parking areas, two (2) uncovered parking areas, reception area, lobby, eight (8) storage rooms, elevators and other facilities. The second floor contains eighteen (18) storage rooms. There are five (5) apartments located on the second floor, designated 201-A through 205-A; there are five (5) apartments located on the third floor, designated 301-A through 305-A; there are five (5) apartments located on the floor, designated 401-A through 405-A; and there are five (5) apartments located on the sixth floor, designated 601-A through 605-A.

"All apartments in Building B are on either the second, third, or fourth floors, and the first floor of said building contains covered parking areas, storage rooms, elevators and other facilities. There are six (6) apartments located on the second floor, designated 101-B through 106-B. There is also a recreational room located on the second floor. There are seven (7) apartments located on the third floor, designated 201-B through 207-B, and there are seven (7) apartments located on the fourth floor, designated 301-B through 307-B."

ARTICLE II

The first page of Exhibit B to the Amended Declaration, entitled "BUILDING 'A' GROUND FLOOR PLAN" and recorded in Official Record Book 607 at Page 2420 of the Public Records of Indian River County, Florida, is hereby

amended by substituting for such page the page entitled "Exhibit A to the Articles of Amendment attached hereto and made a part hereof.

ARTICLE III

The second page of Exhibit B to the Amended Declaration, entitled "BUILDING 'A' FIRST FLOOR PLAN" and recorded in Official Record Book 607 at Page 2421 of the Public Records of Indian River County, Florida, is hereby amended by substituting for such page the page entitled "Exhibit B to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE IV

The third page of Exhibit B to the Amended Declaration, entitled "BUILDING 'A' SECOND FLOOR PLAN" and recorded in Official Record Book 607 at Page 2422 of the Public Records of Indian River County, Florida, is hereby amended by substituting for such page the page entitled "Exhibit C to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE V

The fourth page of Exhibit B to the Amended Declaration, entitled "BUILDING 'A' THIRD FLOOR PLAN" and recorded in Official Record Book 607 at Page 2423 of the Public Records of Indian River County, Florida, is hereby amended by substituting for such page the page entitled "Exhibit D to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE VI

The fifth page of Exhibit B to the Amended Declaration, entitled "BUILDING 'A' FOURTH FLOOR PLAN" and recorded in Official Record Book 607 at Page 2424 of the Public Records of Indian River County, Florida, is hereby amended by substituting for such page the page entitled "Exhibit E to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE VII

The sixth page of Exhibit B to the Amended Declaration, entitled "BUILDING 'A' FIFTH FLOOR PLAN" and recorded in Official Record Book 607 at Page 2425 of the Public Records of Indian River County, Florida, is hereby amended by substituting for such page the page entitled "Exhibit F to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE VIII

Exhibit D to the Amended Declaration, being a tabular statement of the share of the common elements to be attributed to each apartment in both Buildings A and B of the Condominium, is hereby amended by substituting therefor the page entitled "Exhibit G to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE IX

Exhibit E to the Amended Declaration, being a tabular statement of the parking spaces and storage rooms assigned to each of the apartments in both Buildings A and B of the Condominium, is hereby amended by substituting therefor the page entitled "Exhibit H to the Articles of Amendment" attached hereto and made a part hereof.

ARTICLE X

From and after the date of recording of these Articles of Amendment, duly executed, in the Public Records of Indian River County, Florida, each owner as of such date of any apartment in Building A of the Condominium shall be and hereby is confirmed in his, her, its, or their title to such apartment as such title is evidenced by any deed into him, her, it or them as of such date of record in Indian River County, Florida, and according to the legal description of such aparment contained in such deed.

ARTICLE XI

From and after the date of recording of these Articles of Amendment, duly executed, in the Public Records of Indian River County, Florida, each mortgagee as of such date of any apartment in Building A of the Condominium shall be and hereby is confirmed in his, her, its or their status as mortgagee of such apartment or apartments as such status is evidenced by any mortgage as of such date of record in Indian River County, Florida, and according to the legal description of the mortgaged property contained in such mortgage.

ARTICLE XII

For value received, each of the undersigned unit owners in Building A has remised, released, and quitclaimed, and by these presents does remise release, and quitclaim all the right, title, interest, estate, claim, and demand, both at law and in equity, of each of such unit owners of, in, and to the apartment units as described in the Amended Declaration prior to the recording of these present amendments corresponding to the apartment units described in the deeds into such undersigned units owners, to the unit owners of the apartment units as described in the Amended Declaration subsequent to the recording or these present amendments corresponding to the apartment units described in the deeds into such latter unit owners, and to their heirs and assigns forever.

IN WITNESS WHEREOF, all of the owners of apartment units in KENTUCKY CLUB CONDOMINIUM, a condominium according to the Amended Declaration of Condominium recorded in Official Record Book 607, at Page 2370, of the Public Records of Indian River County, Florida, and all record owners of all mortages encumbering the aforementioned condominium apartment units, have executed these presents, the day and year recited upon their several signature pages appended hereto.










BUILDING "A"
