- 1. Rule 12 is amended to read as follows:
- 12. An Owner or occupant shall not cause anything to be affixed or attached to, hung, displayed or placed on the exterior walls, doors, balconies or windows of such party's Home except for ARC approved crank or electric roll down hurricane shutters covering the sliding doors ONLY. Curtains and drapes (or linings thereof) which face on exterior windows or glass doors of Home shall be subject to disapproval by the Board, in which case they shall be removed and replaced with acceptable items.
 - 2. The foregoing amendment to the Rules and Regulations was approved by the Board of Directors at the meeting held on April 13, 2021.
 - 3. All other provisions of the Rules and Regulations are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
